

DATA TRANSFER AGREEMENT

This Agreement is concluded between **Microsec Software Engineering & Consulting Ltd.** (registered seat: 1033 Budapest, Ángel Sanz Briz út 13., company registration number: Cg. 01-10-047218, tax number: 23584497-2-41), as service provider (hereinafter referred to as: **Service Provider**¹), and

- 1.1. Based on the present agreement (hereinafter referred to as: **Agreement**) the Service Provider may provide the following services (hereinafter referred to as: **Services**) to the Subscriber, provided that the Subscriber had concluded the IM Company Information Agreement with the IM Company Service.
- 1.2. The Services provided by the Service Provider:
 - a) company information service as defined in Section 15 (2) of Act V of 2006 on company registration, court proceedings and liquidation (hereinafter referred to as: **Company Act**) and
 - b) company information service as defined in IRM Regulation No 1/2006 (VI. 26.) on the Company Information and Electronic Company Procedure Service and the reimbursement of the costs of company information and
 - c) related services provided by the Service Provider.
- 1.3. Chapter 4 of the Online Company Information Service General Terms and Conditions (hereinafter referred to as: **GTC**) contains the detailed description of the Services.
- 1.4. The GTC contains the general terms of using the Service. The GTC constitutes an integral part of this Agreement. The GTC may be downloaded from the website: <https://occsz.e-ceggyezek.hu/?index>. By signing this Agreement, the Subscriber acknowledges to have read the GTC and expressly accepts its terms.
- 1.5. Provisions regarding service fees (rules regarding payment, delays) are set out in the GTC. The Price List annexed to the GTC contains the fees of the services. The fee limit applicable upon signing the present Agreement is HUF 250,000.

1.6. The Subscriber shall pay for the service based on the invoice issued by the Service Provider by the payment deadline indicated on the invoice, by transfer to the bank account number indicated therein.
